**TRF POLICY**

It is the policy of TRF to own the copyrights in its *technical* publications, and *ID* the contributions contained therein, in order to protect its own interests and those of its authors and their employers, and at the same time, facilitate the appropriate re-use of this material by others.

Now U.S. copyright law requires that the transfer of copyrights in each contribution from the author to TRF be confirmed in writing. It is therefore necessary that you execute either Part A - Copyright Transfer Form or Part B -U. S.
